

## How to Declare Your Statistics Minor

1. Visit [www.ppc.uconn.edu](http://www.ppc.uconn.edu) to declare your minor online
2. Download and print the Statistics Minor Plan of Study form. Go to [www.stat.uconn.edu](http://www.stat.uconn.edu) > Academic > Program Info > Undergraduate > Statistics Minor
3. Bring your completed Statistics Minor Plan of Study form to the Statistics Main Office located in the Philip E. Austin Building, room 323. Leave your form in the box labeled "Undergraduate Advising Form Drop Off," located below the faculty mailboxes.
4. You will be notified by email when your audited and signed form is ready for you to pick up.
5. Bring the signed form to the Registrar's Office located in the Wilbur Cross Building.

**\*\*Please note:**

- You must have already taken Calculus in order to become a Statistics minor.
- Declaration of a Stat minor should be done well before the registration period begins. Declaration during the registration period does not guarantee access to reserved seats.
